Cannabidiol

Due to its properties, cannabidiol (CBD) can contribute significantly to the well-being of the user¹.

MCT Oil

The abbreviation MCT stands for "medium chain triglycerides,". These are triglycerides (or MCT fats) which contain medium chain fatty acids. MCT oil is vegan, has a very low allergenic potential, and is odourless and tasteless.

Directions

Supplement Use

Shake well before use. Draw up the cannabidiol base solution using the pipette bulb (squeezing the bulb) provided. Remove the pipette from the flask and apply up to 0.5ml (for each intake) into a teaspoon by squeezing the bulb again. Place the solution under your tongue. Smear the solution around your lower and upper gums as much as possible. For best results, let absorb for 5-10 minutes before consuming any liquids or food. You can take up to two doses of 0.5ml daily.

Topical Use

Shake well before use. Dispense a few drops onto clean fingertips. Gently work into skin where needed. Suitable for all skin types.

One bottle of SWISS 1876° Oil Drops (10ml) contains approximately 450 drops. This refers to use at room temperature and the bottle (with dropper) or pipette is held vertically. At lower temperatures a deviation may occur due to the change in viscosity of the carrier.

Additional information

CBD is metabolised in the liver where it can inhibit the activity of some liver enzymes. For drugs metabolized in the liver, this process may be slowed down and enhance their effect in combination with CBD.

Care should be taken when combining with the following medicines (the list is not exhaustive):

- Acid inhibitors (Pantoprazole and Omneprazole), slower degradation, therefore stronger effect possible
- Anticoagulants (Marcumar and warfarin), increased risk of bleeding possible

- Anticoagulants (Marcumar and warfarin), increased risk of bleeding possible
- Antiepileptic drugs (risperidone, haloperidol and clobazam), increased plasma levels of antiepileptic drugs possible
- Antihypertensive drugs, CBD can lower blood pressure
- · Analgesics (Diclofenac)

2018 Farm Bill Excerpt

"The Agriculture Improvement Act of 2018 (2018 Farm Bill) authorized the production of hemp and removed hemp and hemp seeds from the Drug Enforcement Administration's (DEA) schedule of Controlled Substances. It also directed the U.S. Department of Agriculture (USDA) to issue regulations and guidance to implement a program to create a consistent regulatory framework around production of hemp throughout the United States."

This bill made some hemp-derived CBD products with less than 0.3 percent THC federally legal.

Glossary Terms

GACP** - stands for Good Agricultural and Collection Practices and provides general technical guidance on growing, collecting and processing of medicinal plants and herbal substances for the sustainable production of herbal products classified as medicines.

GMP** – stands for Good Manufacturing Practices and is a system for ensuring that products are consistently produced and controlled according to quality standards. It is designed to minimize the risks involved in any pharmaceutical production that cannot be eliminated through testing the final product. GMP** covers all aspects of production from the starting materials, premises, and equipment to the training and personal hygiene of staff.

NSF International** - Manufacturers, regulators and consumers look to NSF** for the development of public health standards and certification programs that help protect the world's food, water, consumer products and environment. NSF** provides registration, certification and audit of Good Manufacturing Practices for dietary supplements, personal care products and OTC drugs.

Swissmedic** – They are the Swiss authority for the licensing and monitoring of therapeutic products, ensuring that the therapeutic products they approve are of faultless quality, effective and safe.
